Good Morning, your Honor. Thank you for the opportunity to make this victim impact statement.

The indictment charges the Defendant with 46 crimes – 30 felonies and 16 misdemeanors.

Because the Defendant was charged with a violent class B felony, CPL 220.10 requires that any plea agreement include a plea of guilty to a felony – at least a class D felony.

He plead guilty to one misdemeanor and one violation. I'm devastated. The plea is unacceptable both because the plea violates the law and because the plea fails to hold the Defendant accountable for what he did to me.

I ask the Court to reject this plea bargain and take the case to trial because the Defendant must be held accountable for what he did to me.

He raped me. He raped me three times. He raped me three times in violation of active orders of protection.

He robbed me. He beat me. He threatened me with knives and scissors. He strangled me. He suffocated me. He threatened to murder me. He threatened to cut my throat in this court room. He threatened me in this courtroom.

He committed all of these crimes in violation of orders of protection. He stalked me. He tried to bribe me drop the charges. He tried to kidnap me. He told me that he paid someone \$25,000 to kill me because I refused to drop the charges. This occurred while he was out on bail.

These facts need to be tried. Please take this case to trial, your Honor.

The Defendant has not taken any responsibility for what he did to me. Please take the case to trial and hold the Defendant accountable for what he did to me.

I was his wife. I loved him. And look what he did to me. He raped the hell out of me!

Why do we have laws? Why do judges issue orders? Is the law just good advice? Or are we expected to obey the law?

If the Court accepts this plea agreement, then there is no incentive to obey the law.

If this Court ignores the law, then everybody can ignore the law.

As part of the plea agreement, the Defendant would get 40 hours of ~~counseling~~ *community service*. That's a benefit, not a punishment. 40 hours of ~~counseling~~ *community service* is diabolically lenient. It's unconscionable.

If this Court ignores the Defendant's violations of the Courts' orders of protection, then everybody can ignore a court's order of protection.

I need more than an order of protection. I need justice.

The Defendant needs to spend a long time in prison, thinking about the heinous crimes that he committed against me.

I'm not afraid to go to trial. I'm not afraid to testify. I'm not afraid to tell the truth.

Please reject the plea bargain, your Honor. Please take the case to trial. Please hold the Defendant accountable for what he did to me.

Amr Kandil is a danger to society. Please hold him accountable, so that he cannot rape me again or harm anybody else.
